The Cass District Library Board (“Library Board”) will hold a public hearing on the proposed Library budget for the fiscal year January 1, 2021 – December 31, 2021 electronically on November 18, 2020 at 6:00 p.m. **The property tax millage rate proposed to be levied to support the proposed Fiscal Year 2021 budget will be a subject of this hearing.** A copy of the budget, including the proposed property tax millage rates, is available for public inspection on the Library’s website <https://www.cassdistrictlibrary.org> The budget is also available for public inspection at the Library Administration Offices, Cass District Library, 319 M-62, Cassopolis, MI 49031.

The Library must hold a public hearing before the final adoption of the budget. Any interested person will be given the opportunity to be heard at the public hearing regarding the proposed budget.

Pursuant to the Open Meetings Act, as amended by 2020 PA 228, the Library gives notice of the following:

1. Reason for Electronic Meeting. The meeting and public hearing are being held electronically because of the capacity restrictions and social distancing requirements and as permitted by the Open Meetings Act, as amended by 2020 PA 228. Therefore, the Library wants to ensure participation by the public if the public cannot be physically present.
